In the mean while Mr. Vella will look in to legal proceedings regarding the design/build of the wiring of the system. The fraying of the wires, which is causing the ground faults, has been an issue all along. This matter was passed by the affirmative voice vote of all members present, no nays, no abstain, three absent.

## Attorney's Report

Mr. Vella reported that the letter he sent to Solar World regarding the warranty of the solar panels has received a third response denying our claim. Mr. Vella is going to pursue this matter in small claims court. Either the manufacturer or installer is responsible for how the panels were installed.

Mr. Vella also reported that our temporary note is due August 5<sup>th</sup>, 2015. The amount due is \$1,319,445.83 which includes interest. Currently the Authority has \$1,018,505.64 available for repayment from the excess monies from the note since the project came in under budget and from the FEMA monies the Authority has already received. Ms. Vilanova reported that the Authority is awaiting another \$40,075.09 from FEMA as well as the potential for anywhere between \$47,423.75-\$143,048.45 in additional funds at project closeout. At this time Mr. Vella suggests the Authority pay the monies it has towards the note and then float the remainder which will be approximately \$260,000 - \$300,000 until the project is fully closed out. The Board agreed with Mr. Vella. Mr. Vella will begin the process.

#### Many Mind Creek- NJNG Soil Remediation

Mr. Henderson reported that he attended a meeting with the Authority and NJDEP regarding the project. Items discussed included schedule for the work, duration, method of bypass, and replacement of main after remediation. NJNG advised it would be preparing detailed construction plans and specifications for further review by MCBOA.
