Mr. Dayback reported that there has been no change over the past month and no activity since the last report for the NJNG Many Mind Creek Remediation or Whirl Construction.

The ACOE sent over revised plans for the Port Monmouth Flood Protection Projection. T&M reviewed the plans and comments were forwarded to the Authority by e-mail July 24, 2017 and forwarded to the Corps.

Mr. Dayback reported that the cost proposal from Pure Technologies was made part of the application for funding to the New Jersey Infrastructure Trust Fund. A draft copy of the application to the NJITF was submitted to the Authority for discussion this evening. Once reviewed, and if approved T&M will submit the application.
