### **Attorney**

Mr. Vella reported that the Bond closing is scheduled for October 12<sup>th</sup>, 2018. Once the financing has been secured the Authority will have the ability to draw down on the funds.

## **Engineer**

Mr. Dayback reported that contracts were reviewed by Mr. Vella and sent to Pure Technologies on September 7, 2018 for signature. The contractor must sign and return executed documents, bonds and insurance certificate prior to the Authority signing the contract and a notice to proceed issued. A meeting will be held at the Authority on Tuesday, September 18, 2018 with the Pure Technologies project team to review and discuss the project planning and scheduling. Mr. Dayback has tentatively scheduled a representative from Pure Technologies to attend the October meeting to discuss the same with the commissioners.

Mr. Dayback reported that the plans and specifications for the HVAC design are now complete and ready for public bid. To address the concern of the presence of asbestos containing materials Mr. Dayback presented a proposal to perform a Selective Asbestos Identification Survey. The proposal is for a fixed fee of \$3,850.00. Based on the asbestos findings the removal of the asbestos may or may not be added to the bid. Once the findings are in T&M will put the HVAC proposal out to bid.

Mr. Dayback also discussed how the Authority would like to bid the HVAC project. The Authority decided to bid the project as the HVAC unit itself will be the base bid. The finned tube valves, hot water/boiler and cleaning of duct work will be alternate bids. As far as the start/completion dates the A/C would be done so it would be ready for the spring and then any heat work

On **Motion** by Mr. Scarano, **Seconded** by Ms. Loud-Hayward, the board authorized T&M Engineering to complete the asbestos Identification Survery in the amount of \$3,850.00. This matter was passed by the affirmative voice vote of all members present, no nays, no abstain, none absent.
