AGREEMENT TO RENEW MEMBERSHIP IN THE NEW JERSEY UTILITY AUTHORITIES JOINT INSURANCE FUND

WHEREAS, the New Jersey Utility Authorities Joint Insurance Fund (hereinafter the Fund) is a duly chartered Municipal Insurance Fund as authorized by NJSA 40A:10-36 et seq., and;

WHEREAS, the Monmouth County Bayshore Outfall Authority is currently a member of the said Fund, and;

WHEREAS, effective December 31, 2015, said membership will expire unless earlier renewed, and;

WHEREAS, the Governing Body of the Monmouth County Bayshore Outfall Authority has resolved to renew said membership;

NOW THEREFORE, it is agreed as follows:

MCBOA Regular Meeting of August 17, 2015

- 1. Monmouth County Bayshore Outfall Authority hereby renews its membership in the New Jersey Utility Authorities Joint Insurance Fund for a three (3) year period, beginning January 1, 2016 and ending January 1, 2019* (*12:01 AM).
- 2. The Monmouth County Bayshore Outfall Authority hereby ratifies and reaffirms the Indemnity and Trust Agreement, Bylaws and other organizational and operational documents of the New Jersey Utility Authorities Joint Insurance Fund as from time to time amended and altered by the Department of Insurance in accordance with the Applicable Statutes and administrative regulations as if each and every one of said documents were re-executed contemporaneously herewith.
- 3. Monmouth County Bayshore Outfall Authority agrees to be a participating member of the Fund for the period herein provided for and to comply with all of the rules and regulations and obligations associated with said membership.
- 4. In consideration of the continuing membership of the Monmouth County Bayshore Outfall Authority in the New Jersey Utility Authorities Joint Insurance Fund agrees, subject to the continuing approval of the Commissioner of Insurance, to accept the renewal application of the Monmouth County Bayshore Outfall Authority.
- 5. Executed the 21st day of September, 2015 as the lawful and binding act and deed of the Monmouth County Bayshore Outfall Authority, which execution has been duly authorized by public vote of the governing body.
