2025 AUTHORITY BUDGET RESOLUTION

**Monmouth County Bayshore Outfall Authority
FISCAL YEAR: January 01, 2025 to December 31, 2025**

WHEREAS, the Annual Budget for Monmouth County Bayshore Outfall Authority for the fiscal year beginning January 01, 2025 and ending December 31, 2025 has been presented before the governing body of the Monmouth County Bayshore Outfall Authority at its open public meeting of October 21, 2024; and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$2,173,726.00, Total Appropriations including any Accumulated Deficit, if any, of \$2,173,726.00, and Total Unrestricted Net Position planned to be utilized as funding thereof, of \$0.00; and

WHEREAS, the Capital Budget as introduced reflects Total Capital Appropriations of \$780,000.00 and Total Unrestricted Net Position planned to be utilized as funding thereof, of \$30,000.00; and

WHEREAS, the schedule of rents, fees and other charges in effect will produce sufficient revenues, together with all other anticipated revenues to satisfy all obligations to the holders of bonds of the Authority, to meet operating expenses, capital outlays, debt service requirements, and to provide for such reserves, all as may be required by law, regulation or terms of contracts and agreements; and

WHEREAS, the Capital Budget/Program, pursuant to N.J.A.C. 5:31-2, does not confer any authorization to raise or expend funds; rather it is a document to be used as part of the said Authority's planning and management objectives. Specific authorization to expend funds for the purposes described in this section of the budget must be granted elsewhere; by bond resolution, by a project financing agreement, by resolution appropriating funds from the Renewal and Replacement Reserve or other means provided by law.

NOW, THEREFORE BE IT RESOLVED, by the governing body of the Monmouth County Bayshore Outfall Authority, at an open public meeting held on October 21, 2024 that the Annual Budget, including all related schedules, and the Capital Budget/Program of the) Monmouth County Bayshore Outfall Authority for the fiscal year beginning January 01, 2025 and ending December 31, 2025, is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the said Authority's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

BE IT FURTHER RESOLVED, that the governing body of the Monmouth County Bayshore Outfall Authority will consider the Annual Budget and Capital Budget/Program for Adoption on December 09, 2024.



North Jersey Wastewater Cooperative Pricing System

In 2004, the Passaic Valley Sewerage Commission (PVSC) joined with the Bergen County Utilities Authority and the Joint Meeting of Essex and Union Counties to form the North Jersey Wastewater Cooperative Pricing System (NJWCPS). The NJWCPS is a cooperative procurement program approved by the New Jersey Department of Community Affairs with a goal of utilizing the administrative purchasing services and facilities of PVSC to effect substantial economies in the purchase of goods and supplies. PVSC is pleased to serve as the lead agency of the NJWCPS.

The NJWCPS has advertised and awarded contracts using competitive bidding processes for a variety of goods, equipment and services including: Janitorial Supplies; Various Manufacturer Equipment and Spare Parts; Instrumentation Equipment, Tools and Accessories; Various Manufacturers' Pumps and Motor Repair, Replacement, and Installation; Valves and Accessories; Wireless Monitoring and Alarm Systems; Rental of Mobile Crane with Operator; Various Hose Couplings and Fittings; Safety Equipment and Supplies; Various Bulk Chemicals; and Various Filters. Members of the NJWCPS have access to the terms, conditions, pricing and cost savings provided by these contracts.

As the lead agency of the NJWCPS, PVSC is permitted to accept and approve requests for additional memberships in the cooperative. The procurement contracts awarded under the cooperative are best suited for use by government entities such as municipal utilities authorities, public works departments, and municipal or regional wastewater treatment facilities. The process to add members is not complicated, and PVSC currently operates the cooperative at no cost for the member agencies. The lead agency is also available to discuss individual member questions on an ongoing basis.

The Passaic Valley Sewerage Commission looks forward to building on the success and cost savings of the North Jersey Wastewater Cooperative Pricing System. PVSC welcomes all inquiries about the cooperative from municipalities and other government agencies across the state of New Jersey. A listing of the current membership appears below.
